



Thrillin' Grillin' Raffle FAQs

Q: What is the Alliance Catholic Foundation?

A: Alliance Catholic Foundation is a 501(c)(3) non-profit organization launched by Alliance Catholic Credit Union in 2020 to increase opportunities to minister to the community. Inspired by Catholic social teaching, Alliance Catholic Foundation strives to meet the needs of the neighbors we serve. When you give to Alliance Catholic Foundation, your contributions will go directly to lifting up the poor and vulnerable in our society and supporting a call to family and community. Every dollar raised is put to work with individuals, organizations and causes that uphold the ongoing vitality of the Church today and into the future.

Q: How much does an individual raffle ticket cost?

A: \$10 per ticket for the Thrillin' Grillin' Raffle.

Q: What do I win if my ticket number is chosen?

A: The prize for this raffle is a Blackstone Grill and accessories prize package.

Q: Is there a limit to how many tickets I can purchase?

A: There is no limit to how many tickets may be purchased at a time, per person per raffle.

Q: Who is eligible to purchase a Thrillin' Grillin' Raffle ticket?

A: Anyone who is over the age of 18 and resides in the state of Michigan is eligible to purchase a ticket, with the following exceptions: Present employees, volunteers, and



affiliates of the Alliance Catholic Foundation and Alliance Catholic Credit Union and immediate family members of present employees, volunteers, and affiliates of Alliance Catholic Foundation/Alliance Catholic Credit Union are ineligible to enter. 'Immediate family member' means a spouse, domestic partner, child, grandchild, parent, grandparent, or sibling (including adoptive, in-law, and step-relationships).

Q: When will a winner for the Thrillin' Grillin' Raffle be selected?

A: The raffle will run from June 1 through June 30. The winner will be selected on July 15, 2026.

Q: Is my raffle ticket purchase tax deductible?

A: No portion of the raffle ticket price is considered a charitable contribution for purposes of tax deductibility. To make a tax-deductible contribution, please visit the Alliance Catholic Foundation website.

Q: How can I purchase tickets for the Thrillin' Grillin' Raffle?

A: Raffle tickets can be purchased in branch or via the contact center. Tickets purchased in the Contact Center will be set aside at the branch of your choice and will need to be picked up and filled out in person.
